#### Exclusions:

- Duct work
- Water supply and drain beyond the equipment proper.
- Electrical service beyond the equipment disconnect switch (except control wiring)
- Moving or relocating equipment.
- Any damage due to unexpected freezing. Work made necessary by the enforcement of government codes.
- Devices and controls not furnished by us are EXCLUDED from this agreement unless otherwise specified in the agreement.
- Balancing system airflow other than at the equipment.
- We will not be responsible for system design nor maintaining design conditions through performance of this agreement.

#### General:

- During the term of this agreement, we will take all reasonable precautions to avoid injury to persons and damage to property while on the premises, but we will not be liable for any special or consequential damages.
- We shall not be liable for losses or defects arising out of vandalism, fire, flood, wind, war, riots and acts of God.
- No service will be rendered under this agreement if customer has a past due account.
